

Madam/Sir,

I am directed to refer to MCI's letter No.MCI-37(1)(RI-33)(UG)/2017-Med./160022 dated 15.12.2017 on the subject mentioned above and to convey the approval of the Central Government for renewal of permission for for admission of 3rd Batch of MBBS students against increased intake from 70-100 at Dayanad Medical College & Hospital, Ludhiana under Baba Farid University Health Sciences, Faridkot for the academic year 2018-19 u/s 10 A of IMC Act 1956.

2. The permission is valid for one year and for admitting only one batch of 150 MBBS students during the academic session 2018-19. The next batch of students in MBBS course will be admitted in the college only after permission of Central Government for renewal/recognition.
3. The Government Medical Colleges (except those located in J&K State) shall contribute 15% of MBBS seats for which the renewal permission is granted for all India quota.
4. Admissions made in violation of the above condition will be treated as irregular and action will be initiated under IMC Act & Regulations made thereunder.
5. Discrepancies, if any, may be immediately brought to the notice of MCI and the Central/State Government.



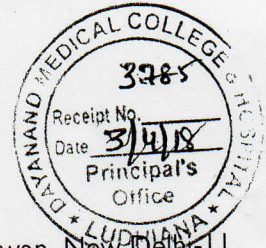
